

Welcome to Keystone Communications! We provide telephone, internet and video services to residents in the Keystone, Garrison and Elberon communities. In order to provide you with these services, we ask that you to fill out an application for service. At this time, if you desire internet service and/or video service, we do require you to have a landline telephone. If you have any questions, please feel free to ask a company representative.

When you complete the telephone application for service, the following procedures will be followed. If you desire long distance service, a letter of credit from your previous phone company or a letter of credit from your bank is required. You may also leave a contact number for your previous phone company in order for us to verify your credit.

We are a cooperative, and with our telephone service, you will automatically be considered a member of our cooperative. You will be asked to pay for installation and one month's local service in advance.

You will be connected to local service only upon receipt of the \$63.30. Local service gives you access to the towns of Keystone, Garrison, Elberon and Van Horne, as well as E911 service.

LOCAL SERVICE CHARGES INCLUDE: Touch-tone service, call waiting, cancel call waiting, call forwarding, three-way calling, and eight number speed dialing. Other options such as caller ID, automatic recall, call waiting caller ID, teen lines, internet, video, etc. are available at additional charges. Please ask our customer service representative if you are interested in any of these options.

IF YOU ARE INTERESTED IN PURCHASING INTERNET SERVICE, YOU WILL BE REQUIRED TO PAY ONE MONTH'S SERVICE IN ADVANCE. IF YOU ARE PURCHASING VIDEO SERVICE, YOU WILL BE ASKED TO PAY THE INSTALLATION CHARGE OF \$37.45 AS WELL AS ONE MONTH'S SERVICE IN ADVANCE. PLEASE ASK FOR APPLICATIONS AND A LIST OF SERVICE OPTIONS FOR EITHER OF THESE SERVICES.

All services provided by Keystone Communications are billed on the first of the month, due by the 20th and subject to disconnect on the 25th. We accept cash, money orders, checks and major credit cards as payment options.
